CBDT - options for allocation of region - regarding.

Staff Selection Commission has recommended 865 candidates (including 36 provisional cases) for appointment to the post of Income Tax Inspector and 501 candidates (including 14 provisional cases) for the post of Tax Assistant in CBDT (Income Tax Department) on the basis of Combined Graduate Level Exam-2024'. As per existing policy, CBDT will make Region/Charge-wise allocation to candidates on the merit-cum-preference basis. Accordingly, as per the addresses of the candidates provided by SSC Regional Offices, option forms were dispatched to the candidates. Option forms had been displayed on the official website also, so that candidates could excise their preference by downloading the proforma. But, option from the candidates listed in Annexure-I and annexure-II are yet to be received. The Competent authority has, therefore, decided to give final opportunity through this notice to submit their preferences in the enclosed proforma latest by 25th Oct, 2025 failing which the allocation would be decided as per the discretion of the Competent Authority.
